Calculated based on the aggregate of ordinary share capital and the total proceeds raised from the issuance of the USD Offshore Preference Shares, in which the total amount of proceeds raised from the issuance is converted into Renminbi at the central parity rate between Renminbi and U.S. dollars of RMB6.9028 to US\$1.00 as published by the China Foreign Exchange Trading Centre on 14 December 2016.

3. Based on the initial conversion price determined with reference to the average trading price of the H Shares of the Company for the 20 trading days preceding the publication of the Board resolution approving the issuance of USD Offshore Preference Shares, i.e. HK\$7.56 per share (equivalent to approximately RMB6.28 per share, using the cross rate between Hong Kong dollars (HK\$1.00 to RMB0.83040) and U.S. dollars (U.S.\$1.00 to RMB6.4358) based on the RMB central parity rate published by the China Foreign Exchange Trading Centre on the trading day immediately preceding the publication of the Board resolution approving the issuance of USD Offshore Preference Shares (*The exchange rate calculated from the above definition is approximately (after rounding) U.S.\$1.00 to HK\$7.7502.*).
